

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.thelegalbillinggroup.com/>, and The Legal Billing Group and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Legal Billing Group include <https://www.thelegalbillinggroup.com/>. The The Legal Billing Group website is a Law Firm Management Services site. By using the The Legal Billing Group website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, The Legal Billing Group may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase The Legal Billing Group's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

Sharing Information with Third Parties

The Legal Billing Group does not sell, rent or lease its customer lists to third parties.

Automatically Collected Information

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
